The Problem: A negligence case in which the plaintiff is the parent of a deceased teenager. Plaintiff is suing the pharmacy that supplied the teenager's medication. MONDAY, SEPTEMBER 5: REGISTER & SUBMIT INTENT TO COMPETE FORM

- ✓ **Register** for the Mock Trial Comp. Internal Class (6645) no later than September 5.
- ✓ **Submit an Intent to Compete form by** *Monday, September 5*; hard copies are available in the Distribution Center across from Records and in Dean Johnson's office (STU207) with soft copy posted on the portal page. Forms must be returned to either Dean Johnson or the Distribution Center.
- ✓ Students participate in teams of two and must supply two witnesses.
- ✓ Requests to register after the deadline will be at the discretion of Dean Johnson.
- ✓ After you are registered, continue to check the Portal for announcements. Answers to factual questions will be considered stipulations binding upon all competitors.
- ✓ This is a competition for upper-level students only. 1Ls cannot compete in this competition, although they are encouraged to participate as witnesses.

FRIDAY, SEPTEMBER 9: PROBLEM POSTED ON THE PORTAL SITE

✓ Each team will be responsible for preparing BOTH the Plaintiff and the Defendant side of the case. Each student will conduct an opening <u>or</u> closing statement, as well as a direct <u>and</u> a cross examination.
